APPENDIX TO THE GENERAL CONDITIONS OF SALE FOR THE INSCRIPTIONS ON THE WALL OF MIGRANTS

Version 1.0 of May 5, 2021

1. Object

This appendix to the General Conditions of Sale of the Association "*La Grande Famille de Procida & Ischia*" is specific to the Monument "*The Wall of Migrants*", located vicolo San Domenico in Procida, Italy, and to the associated website "The digital Wall", accessible from the Association's website

This appendix details the rights and obligations of the Association and of the buyer in connection with the sale of the registration service of a migrant ancestor on the Monument.

2. Obligations and rights of the Association

The Association owns the registration media attached to the Monument and the management of "The digital Wall" website.

The Association is responsible for the technical conditions of construction, management and maintenance of the Monument and the inscriptions made on those medias.

3. Obligations and rights of the buyer

Subscription to the registration service of a migrant ancestor on the Monument is reserved exclusively for members of the Association, up to date with their subscription.

The buyer pays the requested amount which is considered a contribution to the construction, management and maintenance of the Monument.

The buyer agrees to provide the useful, mandatory, and optional information to generate the biographical sheet associated with his migrant ancestor on "The digital Wall" website.

The buyer cannot claim ownership of the registration of his migrant ancestor. He does not have the authorization to contest the technical and esthetic choices of the inscriptions on the Monument.

4. Registrations

Applications for registration of a migrant ancestor on the Monument are subject to the approval of the Administration Council, which reserves the right to request additional information if necessary and to reject incomplete or unjustified requests.

Once a request has been validated by the Administration Council, the registration of a migrant ancestor on the Monument is considered final.

The Administration Council, in its role of management and maintenance of the Monument, has the capacity to modify or delete an inscription of the Monument, in the event of dispute, error or non-compliance.

The biographical files recorded on "The digital Wall" website can be updated at the initiative of the purchasing Member up to date with their subscription, after validation by the Administration Council.

5. Tariffs

The tariffs for registering a migrant ancestor are those in effect on the day the order is taken. The Association grants itself the right to modify the prices at any time. However, it undertakes to invoice the services ordered at the prices indicated when the order is recorded.

6. Completion time

The Association cannot provide a specific deadline for registering a migrant ancestor on the Monument. Indeed, any new registration depends on the number of registrations pending, their completion, their transport to Italy and their fixation to the Monument. However, the Association will notify the buyer of the estimated execution time.

The buyer accepts the time necessary for the successful completion of the registration of his migrant ancestor on the Monument.

The Association informs the buyer once the registration has been completed and fixed on the Monument by sending him a registration certificate.
